Attendees: Barilynn G, CAM Julie D, Plaza Property Services Owner Andrew B, approximately 12 owners on Zoom

The draft 2025 budget proposed by Plaza Property Services was reviewed. Some line items that may need to be adjusted are:

- Add a line item of about \$4200 for a yearly audit.
- Add a item for the Comcast internet access.
- Determine if amount for McCall's Termite Bond covers the buildings which it had in the past or needs to be adjusted. ** Confirmed after the meeting it is included.
- Check if the electrical gang boxes at the end of each building is owners or Association responsibility as repairs are needed.
- Possibly adjust amount for mulch as governing documents section 6.2 states mulch is owner's responsibility around their property.

The <u>draft budget estimated</u> the 2025 monthly HOA fee to be \$295.

The Board will meet December 11 to approve the final budget and 2025 fees.

- 1) Soft plastic ACCEPTED
 - Shopping bag
 - Overwrap from packages like toilet paper, napkins, paper towels & shipping cases
 - Resealable bags (without the zipper)
 - Pharmacy, bread, produce & dry-cleaning bags
 - Newspaper sleeves
 - Ice bags, salt bags & wood pellet bags
 - Air pillows & bubble wrap

Soft Plastics NOT Accepted: Drinking bottles, Food containers, Plastic cups, lids or straws, Jugs, Hard or rigid plastics

- 2) Paper ACCEPTED
 - Paper bags
 - Newspapers
 - Ad inserts
 - Publix recipe cards

Paper NOT Accepted: Drinking cups, Hardcover books. Paper envelopes with bubble lining

- 3) Foam ACCEPTED
 - Egg cartons
 - Takeout trays and cups
 - Meat trays

Foam NOT Accepted: Paper or plastic egg cartons, Lids & straws that come with foam cups, Packing peanuts, Large foam blocks used in electronics packaging
